

Companion Piece – Law Suite Pleading

The Case to be made is as follows

A Criminal Conspiracy defined by the Federal Government is defined as an intentional agreement between two or more persons to carry out the criminal objective along with an overt act in furtherance of the conspiracy. This law can be found in Section 371 of Title 18 of the United States Code (USC), which states: "If two or more persons conspire either to commit any offense against the United States, or to defraud the United States, or any agency thereof in any manner or for any purpose, and one or more of such persons do any act to effect the object of the conspiracy, each shall be fined under this title or imprisoned not more than five years, or both."

This makes it so clear that what has been going on over the past five years does in fact fit the above definition.
